Exhibitors who wish to stay later on Saturday are welcome to do so. Security will be provided Saturday night .

Please read the show rules and regulations, complete the application and return it to Wallingford Center, Inc. by August 15, 2010.

SHOW RULES AND REGULATIONS

1. All merchandise must be handmade. No imports or kits will be allowed.
2. We are requesting two pictures of your work and one of your booth set-up. All applications will be reviewed by the **Celebrate Wallingford Craft Committee**. All decisions will be final. Applications must be received by **August 15, 2010** to be considered. Acknowledgment of your application and acceptance or rejection will be made by return mail.
3. Tables, chairs, displays, sun protection, etc. must be provided by the exhibitor. All tents must be free standing, stakes are not allowed. Please advise if you have special needs or requirements.
4. Exhibitor setup time is **7:00AM** on Saturday October 2nd. No cars are allowed on site after 9:00AM. Take down is **6PM** on Sunday October 3rd. **Please be prepared with a hand truck, some spaces may not be accessible by car. Unload your vehicle and move your vehicle promptly.**
5. Exhibitors must remove their cars to designated public parking areas. No vehicles on site before appointed breakdown time. Exhibitors are responsible for cleaning their area after the show.
6. It is the exhibitor's responsibility to obtain a State sales permit and tax ID number.
7. Exhibitors applications must be accompanied with **\$150.00** fee which will be returned if you are not accepted for Celebrate.

A 10' X 10' space will be provided for each exhibitor, with a fee of **\$150.00** for both days.
